IMPORTANT LEGAL NOTICE

Pursuant to section 36(4) of the Act, a decision of the Minister to attach, vary or revoke a condition of an accreditation or authority (including a licence or registration) takes effect at the expiration of one month from the date on which notice is given under section 36(3) of the Act, but if an application for review of the decision is made the South Australian Civil and Administrative Tribunal (the Tribunal) may suspend the operation of the decision until the application is determined.

Pursuant to section 43 of the Act, a person aggrieved by a decision of the Minister to attach, vary, or revoke a condition of an accreditation or authority (including a licence or registration) may apply to the Tribunal for a review of that decision within one month after the making of the decision (unless the Tribunal decides to dispense with the requirement that the application be so made).
