## **Kangaroo Island Business Sustainability Program**

A new program to help small businesses on Kangaroo Island identify areas where they can reduce costs and environmental impacts was launched in mid September.

Forty island businesses are taking part in the 12-month Business Sustainability program which involves audits, workshops and training in areas of waste, water and energy management, as well as chemical use and transport.

The aim of the program is to assist businesses to identify efficiencies for financial and environmental benefits with a particular emphasis on energy, water and waste management.

## **Seagrass diving on the Yorke Peninsula**

In 2004, the Northern and Yorke NRM Board sponsored the EPA to undertake aerial photography of seagrass on the western side of the Yorke Peninsula. In late August 2007, EPA marine scientists dived at Wallaroo Bay, Moonta Bay and Port Broughton to verify the density of seagrass from the air in 2004. The main aim of the project was to inspect the health of seagrass beds along the Yorke Peninsula.

## **EPA video streaming**

## **Houseboat audits**

The EPA began auditing houseboats along the River Murray in May 2007 to ensure houseboat were compliant with the Code of Practice for Vessels on Inland Waters (2003). The Code requires houseboats to have a blackwater disposal system that meets specified standards. The audit was conducted over two days and began in the Renmark region.

In total, 50 houseboats were audited, revealing only two vessels complied with the Code of Practice, and 31 had a technical breach of some kind. However, all audited vessels maintained a blackwater disposal system of some sort. Seventeen vessels were unattended, requiring officers to conduct an inspection at a later date.

Another houseboat audit will be conducted in November 2007.

## **EPA accredited licence**

On 16 August, the EPA awarded its first accredited licence to The Marina Hindmarsh Island. The Marina received accreditation for best practice environmental management standards.

The accredited licence entitles businesses to a 50 percent reduction in EPA licence fees, less prescriptive licence conditions and a minimum 5-year licence with an assurance of no change to licence conditions.

The Marina Hindmarsh Island is the first business in South Australia and the first Marina in Australia to receive an accredited licence

## **Pesticide handbooks**

The EPA's Watershed Protection Office has released a set of handbooks to assist South Australian industries and land holders use pesticides safely and efficiently.

Three handbooks were developed in consultation with industry and provide necessary advice on how to reduce the environmental impacts from spraying pesticides.

## **EPA regulatory monitoring requirements**

In late August, the EPA held presentations on new regulatory monitoring requirements. The EPA is working to improve imposed licensee monitoring requirements so that is risk based, cost effective and outcome focussed.

The new requirements aim to remove monitoring from low risk activities and facilities, reduce independent verification requirements and reduce report frequency in line with risk.

## Dust suppression forums

The EPA and SA Water have hosted forums on water efficient methods of dust suppression. The forum was held for companies that are licensed under the Environment Protection Act (1993) and are considered to generate significant levels of fugitive dust as part of their operations.

The forums aimed to give attendees a better understanding of EPA and SA Water requirements to conserve water and suppress dust. The forums also provided the EPA and SA Water with a clearer understanding of the needs and actions of industry when they suppress dust and use water.
